# CALL FOR APPLICATION FOR THE PARTICIPATION TO "ERASMUS+ BLENDED INTENSIVE PROGRAM" (BIP) AT THE UNIVERSITY OF NAPOLI FEDERICO II DIRECTED TO MASTER STUDENTS

**CONSIDERED** the Decree of the Director of the Department of Political Sciences n.88 dated 02.04.2025 with which this call for application is issued;

#### DECLARES

#### ART.1 SUMMARY

This call for applications announces the opportunity to participate in the Erasmus+ Blended Intensive Program (BIP) titled **"Advanced Sports Analytics."** BIPs are short- term intensive study programs that combine in-person and online components.

The program primarily targets students from the following institutions: University of Naples Federico II, Italy; Università degli Studi di Napoli Federico II, Italia, Instituto Politécnico de Viana do Castelo, Portogallo, IE University, Spagna, International school for social and business studies, Slovenia, Technische Universität Dortmund, Germania, Technische Universität München, Germania, Athens University of Economics and Business, Grecia.

Eligible applicants are students currently enrolled in the first and second years of master's degree programs for the academic year 2024/2025 at their respective universities. Each university will select eligible students to participate in the program.

All the activities will be hold exclusively in English, thus knowledge of English language (B2) is required. The students that will successfully complete the program (virtual and physical mobility- both mandatory- and final paper) will receive 3 ECTS.

#### 2. ADMISSION REQUIREMENTS

To be eligible for participation, applicants must be students of Università degli Studi di Napoli Federico II, regularly enrolled in the 1st and 2nd year of the Master's degree program in *Statistical Science for Decision Making* and Master's degree program in *Public Administration and Labour Sciences* for the academic year 2024/2025.

# **3. APPLICATION PROCEDURE**

Interested students are required to submit their application by the <u>deadline of 05/05/2025</u> <u>at 12:00</u>. Applications should be sent to <u>maria.iannario@unina.it</u> and must include the following documents:

- Curriculum Vitae, including documentation of study progress, downloaded from the SEGREPASS website.
- Motivational letter in English (maximum 250 words).
- A valid personal identity document.

Following the submission of applications, online interviews will be conducted to assess the English language proficiency of applicants. <u>The date and time of these interviews will be published on the departmental website starting from May</u> 7th.

Only applicants who have achieved a minimum score of 50/100 for the evaluation of academic career and motivational letter will be admitted to the oral interview. Applications with incomplete documentation will be rejected.

# CRITERIA FOR THE FORMULATION OF THE RANKING

The Commissions will assign the score as follows:

- Max. 40 points for the evaluation of the academic career and Curriculum Vitae.

- Max. 40 points for the motivational letter;

- Max. 20 points for English language knowledge, assessed during the interview. Applicants will be considered eligible for the program if they obtain a total score of 70/100.

#### 4. PUBLICATION OF RANKINGS

Final Rankings will be published on the Department's website by the 20th of May.

# **5. PROCEDURE SUPERVISOR**

# 6. DATA PROCESSING

MANDATORY PROVISION OF DATA AND CONSEQUENCES OF ANY REFUSAL: the processing of personal data is mandatory for the purpose of assessing the requirements for participation in the aforementioned call.
