"ERASMUS+ BLENDED INTENSIVE PROGRAM" (BIP) AT THE

ART. 1 SUMMARY

This call for applications announces the opportunity to participate in the Erasmus+ Blended Intensive Program (BIP) titled "**Advanced Statistical Modeling for Sustainable Finance (ASMSF)**" BIPs are short-term intensive study programs that combine in-person and online components.

The program primarily targets students from the following institutions:

- University of Economics, Bratislava (Sending institution)
- Babes-Bolyai University Cluj-Napoca, Romania

Eligible applicants are students currently enrolled in the first and second years of master's degree programs for the academic year 2025/2026 at their respective universities. Each university will select eligible students to participate in the program.

In-presence activities will take place during 7-11 September 2026 at the Department of Political Science, UNINA. A full description of the course can be found at the link <https://indico.unina.it/event/116/overview>

All the activities will be hold exclusively in English, thus knowledge of English language (B2) is required. The students that will successfully complete the program (virtual and physical mobility- both mandatory- and final paper) will receive 3 ECTS.

2. ADMISSION REQUIREMENTS

To be eligible for participation, applicants must be students of Università degli Studi di Napoli Federico II, regularly enrolled in the 1st and 2nd year of the Master's degree program in *Statistical Science for Decision Making* and Master's degree program in *Public Administration and Labour Sciences* for the academic year 2025/2026.

Nr. 3 students will be selected

3. APPLICATION PROCEDURE

Interested students are required to submit their application by the deadline of 05/05/2026 at 12:00. Applications should be sent to dip.scienze-politiche@unina.it and must include the following documents:

- Curriculum Vitae, including documentation of study progress, downloaded from the SEGREPASS website.
- Motivational letter in English (maximum 250 words).
- A valid personal identity document.

Following the submission of applications, online interviews will be conducted to assess the English language proficiency of applicants. The date and time of these interviews will be published on the departmental website starting from May 7th.

Only applicants who have achieved a minimum score of 50/100 for the evaluation of academic career and motivational letter will be admitted to the oral interview. Applications with incomplete documentation will be rejected.

CRITERIA FOR THE FORMULATION OF THE RANKING

The Commissions will assign the score as follows:

- Max. 40 points for the evaluation of the academic career and Curriculum Vitae.
- Max. 40 points for the motivational letter;
- Max. 20 points for English language knowledge, assessed during the interview.

Applicants will be considered eligible for the program if they obtain a total score of 70/100.

4. PUBLICATION OF RANKINGS

Final Rankings will be published on the Department's website by the 15th of May.

5. PROCEDURE SUPERVISOR

Maria Iannario is responsible for any fulfillment related to this call for applications which does not fall under the responsibility of the Examining Boards. The aforementioned may assign in writing to another employee of the organizational unit the responsibility for the procedural requirements.

6. DATA PROCESSING



For these reasons, consent to the processing of data is not required. Any refusal will make it impossible for the University to fulfil these purposes and participation in the program.
